ASSUMPTION OF RISKS: I, the Applicant, am aware that paddle sports including outrigger canoeing involve inherent risks, dangers and hazards including, but not limited to; variable weather conditions; variable water conditions including high water and floods; natural objects both exposed and underneath the water surface; equipment failure, whether borrowed, rented or owned by the participant; impact or collision with other participants; the failure to paddle safely or within one's ability; negligence of other participants; and **NEGLIGENCE ON THE PART OF VERNON PADDLING CENTRE OR ITS MEMBERSHIP INCLUDING THE FAILURE ON THE PART OF VERNON PADDLING CENTRE AND ITS MEMBERSHIP TO SAFEGUARD OR PROTECT ME FROM ANY RISKS, DANGERS AND HAZARDS OF OUTRIGGER/OTHER PADDLE SPORTS/ CANOEING.**

I am also aware that the risks, dangers and hazards exist throughout the course of outrigger canoeing activities and these risks, dangers and hazards are unmarked in any way. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage and loss resulting therefrom.
